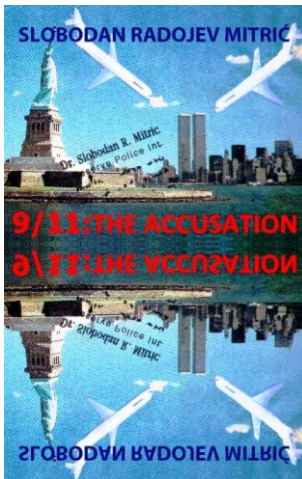

**Amsterdam May 18, 2011** – Less than a week before it will be presented at [BookExpo America](#) (Author’s Booth #5048) in the Javits Center from May 24 to 26 in New York City, the true crime and counter-espionage roman “[9/11: The Accusation – Bringing the Guilty to Justice](#)” by Slobodan Mitric has finally “rolled off the press”. The publisher Robert Jan Kelder of the Willehalm Institute Press Foundation and NovaGlobe Founder Iwanjka Geerdink from The Netherlands, who will be manning the stand with the possible support of a New York lady in waiting, will roll up three banners to highlight their case (see the attachments). On the back flap of this advanced edition, the Serbian-born, Amsterdam-based author living in exile has issued the following urgent appeal:
